 "Employer to remit employer contribution reports and premiums. Beginning January 1, 2025, for each employee, an employer shall remit employer contribution reports and premiums in the form and manner determined by the administrator. Employer contribution reports and premiums must be remitted quarterly. 3. Premium amount. The following provisions govern the premium amount. A. Beginning January 1, 2025, the premium amount may not be more than a combined rate of 1.0% of wages." For Monhegan School that would be no more than \$1,440.00 in 24-25.
